Thanks for this. I have made a couple of comments and some suggested changes for consideration, in particular to the order of the undertakings.

I wonder whether we might use the letter to reinforce the fact that this is one final opportunity to get this right. It does that to an extent but my view would be that we could make more of it. One request for assessment is, quite rightly, not usually the basis for enforcement action but what we are saying here is that we have previously advised IEL of the real risk of non-compliance that is inherent in the business model and they did not take that advice presumably because they underestimated the risk, the complaint we received is demonstration that we were right and these undertakings are their final opportunity to ensure future compliance.

Without a bit more weight behind our arguments here, it might look to the untutored or mischievousieye that we are simply going to give them chance after chance. Worse, it might let IEL underestimate where they are up to.







I agree with Dayid's suggestion for an amendment but did have a couple of other suggestions for minor changes to the text. A tracked changes version is attached. None of these are sticking points if they cause you problems.
